### **Travel Directions:**

The Mizzou Aquatic Center is located in Columbia, Missouri, on the University of Missouri Campus

From the west, take I-70 to the Stadium Drive Exit South (in Columbia), turn left on Providence, and turn right on Rollins. The parking facility and recreation center are on the right.

From the east, take I-70 to the Highway 63 Exit South (in Columbia) to the Stadium Drive exit. Turn right on College, left on Rollins. The parking facility and recreation center

### **Facility:**

The meet will be held at the Mizzou Aquatic Center. The facility features two eight-lane, 25 yard pools with non-turbulent lane lines. A fully automatic timing system will be utilized, with 2 manual timers per lane serving as a backup. The facility includes a diving well that will be available for swimmer warm up/warm down during the meet. No diving will be permitted. Swimmers **MUST** be quiet during starts. **Abuses of these rules will result in the pool being closed for the duration of the meet.**

Seating is available for 1,000+ spectators in the mezzanine area above the pools. **No lawn chairs, coolers or swimmers will be allowed in the spectator area. NO camping out in the spectator area.** No spectators will be allowed on the pool deck. No flash cameras may be used **at any time** during the meet. . Locker rooms will be available for changing. No shaving will be allowed on meet premises. No video recorders or cell phones with video cameras will be allowed in the locker rooms.

Each team will be given a designated area in the team area for their team. Space will be allotted as to number of District Swimmers. In the gym the upper track is off limits along with any area marked as off limits. Lawn chairs may be brought into each team's designated area. Food concessions will be available during all sessions. Vendors will also be selling merchandise in the team area.

There will be areas of the Mizzou Recreation Complex marked as off limits. Please ensure that all swimmers and visitors adhere to these signs and partitions that will be in place.

No smoking is allowed in any area of the building. Medical personnel will be on duty at all times during the meet.

## **Coaches:**

Per Illinois/Missouri Area rules, only certified coaches and meet officials will be permitted on the main pool deck during the meet. Coaches must receive coaches' clearance of certification from Jeanette Mix. **Deck passes will only be issued to qualified coaches that meet all certification requirements.** There will be a hospitality room for coaches and meet officials only.

## **Swimming Schedule:**

Championship Meet Format, with prelims being swam Saturday and Finals Sunday. The exception being the Time Trial events will be swam on Saturday following session 1. Prelims will consist of championship seeding using 8 lanes for all swimmers. Swimmers who place in the top 16 of each event on Saturday will qualify for finals or consolation finals on Sunday. In the event that an alternate advance to the finals, swimmers from consolation finals will be moved into finals, however, there will be no alternates moved up for the consolation heat. Alternates will not be penalized for a "no show" if called upon to participate in finals.

Dive blocks will be available on both ends of the West pool during finals on Sunday.

Time trials for qualification for YMCA Nationals will be held on Saturday 30 minutes following the conclusion of session 1. **Swimmers in these events must provide their own timers and lap counter (if needed). See attached information related to time trials.**

## **Bull Pen:**

There will be a bullpen for each pool in the crash area.

## **Entries:**

The entries, entry fees, time trials form, summary of fees form and officials list must be received by **February 24, 2010**. The entries must be submitted electronically and may be provided on computer disc or electronically via e-mail to the Entry Chair. Submission format is Hytek Commlink file, as per district rules. A printed copy may also be sent, but the electronic file is the official team entry. It is the responsibility of each team to check their entries for errors. There will be no additions or changes once the entry deadline has passed. No deck or late entries will be permitted. Updated times will be accepted through March 2<sup>nd</sup>.

For time trials please email the form along with your entries to entries email at JCAY@live.com.

All coaches be advised that further entry information and reports will be emailed once the entry deadline has passed.

Per the district by-laws, all entry fees and required forms must accompany the official entry. A late fee of \$100 will be assessed to any team that does not meet the entry deadline. The late fee will be made payable to the St. Louis District Swim Committee.

Exhibition swimming is prohibited. Swimmers may compete in four events, only three of which may be individual events. Each association may enter two (2) relay teams per relay event. Only the "A" relay is eligible to advance to the Area Meet. There is no limit on the number of swimmers that may be entered in each individual event per team, but coaches must designate area entry by fastest times only. Time Trial events do not count against the number of official events a swimmer may compete in.

A swimmer's age as of **December 1, 2009** determines the age group for competition. Swimmers must meet all Area eligibility requirements including YMCA full privilege membership in good standing, required meet participation, and amateur status rules. In individual events, a swimmer may only swim in one competitive age group. In relay events, a swimmer may swim up one age group (or two age groups for 11-12's only). The 8 & under and 9-10 age groups can not swim up 2 age groups. No swimmer may compete in more than one relay event per relay cluster (e.g. only one free or medley relay).

Scratches are allowed for MEDICAL REASONS only and must be approved by the meet referee. However, there will be no refunds of entry fees given. **Official scratch sheets will be provided at the meet and must be turned in regardless of whether or not a team has scratches for that session.** Scratch sheets must be turned in to the meet referee 30 minutes before the start of the session. A no-show for an event removes the swimmer from the balance of the meet. Declared false starts may only be used in prelims and swim-offs. The declared false start must be in writing to the Meet Referee or Deck Referee before the heat for which the declaration is being made is called to the blocks

This will be an USA Swimming approved meet (USA swimming, Missouri Valley Swimming sanction number \_\_\_\_\_). Those teams that want their swimmers swims observed and times recorded in the USA Swimming data base (SWIMS) must provide the name (first, middle, last), date of birth, and USA Swimming athlete registration number with their meet entries. Please do not build an ID in Team Manager if the swimmers are not registered with USA Swimming as this will delay the process of getting times submitted into SWIMS.

There will be a \$5.00 entry fee into the Aquatic center for all non-swimmers ages 18 and over. This fee will cover the entire weekend along with entering them in a drawing for some fantastic door prizes.

### **Entry Fees:**

Entry fees are \$4.00 per individual event and \$16.00 per relay. There is also a \$12.00 swimmer surcharge. Entry fees **must** accompany entry file. Please turn in the team entry fee sheet with checks made out to "STPA". Entries must arrive by Wednesday, **February 24, 2010**. Entries may be hand-delivered to the Jefferson City Area YMCA Knowles Facility no later than 7:30 p.m. Wednesday, **February 24, 2010**. The officials form must be received by Ron Marion, no later than **February 24, 2010** or your team will be subject to the \$100.00 late fee for the District Meet. Failure to return this form will result in your team not being entered in the District Meet.

## **Timers:**

**Timers will be required from all teams. Number of timers required from participating teams will be based on number of swimmers attending. Timers will report to the blocks when the first event (8:45 AM) is called to the staging area at the start of each day.**

We will have two shifts of timers for the East Pool events and two shifts of timers for West pool events in session 1 on Saturday, and two shifts of timers for Sunday's finals. **There will be a fifteen minute break in each session** at which time the replacement timers will need to report to the blocks.

**Swimmers competing in the 500 freestyle events will need to provide their own lap counters**

**SWIMMERS COMPETING IN TIME TRIAL EVENTS MUST PROVIDE THEIR OWN TIMERS AND COUNTERS IF NEEDED.**

## **Swimmers Conduct:**

It is expected that all swimmers and spectators alike will exhibit courteous sportsmanship at all times. Running, ball-throwing, horseplay and vandalism will not be permitted in any area of the facility. Radios, CD/MP3 players, etc. will be permitted with **HEADPHONES ONLY**. No food or drink is allowed in the team area.

Parental supervision of the swimmers in all areas is a requirement for team participation. Each team is required to have two (2) parents with their team at all times in the team area.

All swimmers are required to report to the bullpen when the event is called.

**These rules will be strictly enforced. Any violation of these rules or codes of conduct may result in the disqualification of a swimmer or an entire team by the District Committee.**

### **Awards & Scoring:**

Points and awards will be rewarded to the top 16 finishers in each event on Sunday.

All age group and team trophies will be presented after the conclusion of finals on Sunday. Coaches or a pre-designated parent only may pick up individual awards following the completion of finals.

All teams will receive one copy of total meet results on Sunday. Teams may bring 1 disk/thumb drive for computer results of the meet to pick up Sunday with awards. **Please be sure to label your device for pick up.**

During the meet, results of each event will be posted in the team area for spectators and swimmers and on deck for coaches.

### **Rules:**

District and Area Championships shall be governed by current Illinois/Missouri Area YMCA Bylaws, St. Louis YMCA District Bylaws, National YMCA "Rules that Govern Competitive Sports," and the current NCAA Swimming Guide.

### **Liability:**

The Jefferson City Area YMCA, the University of Missouri, Mizzou Aquatic Center and the St. Louis District Swim Committee do not assume any responsibility for injury and lost or stolen articles.

### **Hospitality:**

A Hospitality Room will be available for coaches and meet officials.

### **Heat Sheets:**

Heat Sheets will not be sold at the meet. Once entries have been submitted the heat sheet will be available online at [jc-barracudas.com](http://jc-barracudas.com). All parents will need to print out their own copy if needed. The heat sheets will also be posted around the crash area and spectator viewing area for anybody who forgets. We will also have a limited number available for sale at the meet for those who would like to purchase one.
